Green Financing for Investments

Long-term financing, primarily backed by **government guarantees**, to support the construction, acquisition, and revamping/repowering of **renewable assets**. The financing is structured according to **project finance** principles, ensuring project segregation and optimizing leverage.

Green Financing for liquidity

Medium-term financing, structured as an unsecured loan and primarily backed by **government guarantees**, to support the operational liquidity and/or working capital needs of companies operating in the energy transition sector.

Surety Bonds

Issuing guarantees to support businesses and private individuals for obligations assumed towards third-party creditors, including those relating to **participation in competitive procedures** in the renewable energy sector (e.g., the **FER-X tender**).

Certifications and attestations

Specialized service for (i) **certification of Economic-Financial Plans** (PEF), aimed at ensuring the reliability and financial sustainability of investment projects, with particular reference to the Energy, infrastructure and PPP sectors and (ii) **certification of the financial and economic capacity of the sponsor** of the initiatives.

M&A Advisory

Assistance in all phases of M&A processes, both buy-side and sell-side. This includes preliminary opportunity analysis, economic and financial assessment with the preparation of informative material and business plans, transaction structuring, and negotiation management with counterparties, including any advisors involved.

Debt Advisory

Assistance in seeking financing partners and **structuring corporate and project financing**, both senior and junior, ensuring tailored solutions for every need. This service also includes assistance in negotiating the best financing terms, with particular attention to commissions, processing fees, term, and pricing, in order to optimize the financial structure of the transactions.
